## **Meeting Topic & Summary**

**Topic:** The Association & Museum Joint Marketing Opportunities

**Summary:** Captain Matthews would like to see us work and benefit together on a marketing campaign. This campaign will enhance both out positions and awareness in the communities at large. This be very beneficial as our partnership continues to grow.

**Action Items:** We will explore and come up with ideas we can put into action.

Topic: The Possibility of an Association Display case in the Museum to showcase our Partnership

**Summary:** Captain Matthews & Desmond thought this was a good idea. Captain suggested we put it on the main floor in one of the display rooms, and we use some of our Artifacts already in Storage to display.

**Action Items:** The Museum will provide us a case to put some of our 9th & 10<sup>th</sup> artifacts in and let us know when ready.

Trooper Amos will work with the Executive Bord on what we should pull from storage to display (we discussed some ideas) and she will go and set it up. (Others may be involved as will)

Topic: The Museum & Association's Storage & Distribution of National Artifacts Written Agreement

**Summary:** The Museum suggested and I am in agreement we should have a written guideline for the National Artifacts in Storage which will include the following:

- 1. Yearly Storage fee and payment Date
  - a. If any changes to fees, dates, ect. What is the acceptable notification process for changes to take effect?
- 2. How are the Artifacts to be used and by whom?
  - a. Chapters for Reunions
    - What is the outlined process for Chapter to request National artifacts for display at reunions, costs - who responsibility, insurance liabilities, shipping ect.
  - b. Who, if anyone else can request National Artifacts?
- 3. A Liaison from the Houston Chapter will be assigned to work with us when Artifacts need to be used.

Action Items: Trooper Amos will work with the Executive Board assigned committee and The National Museum to compile and agreement and all necessary required documents.

It will be approved by the Association Executive Board and the Museum, then jointly signed.

Topic: Ongoing Virtual Museum/Association Historical Presentations

**Summary:** Captain suggested we utilize all this historical knowledge within our Association and Museum troopers. By Having an ongoing Virtual History Day Presentation, (Monthly, Quarterly) where all the Chapters and our member-at-large members can get involved in preparing a presentation to present as well utilizing our national Historians who can prepare and do Community Presentations virtually. We will work through/with the Museum to do presentations. For example, similar to what we did for this past reunion, Trooper Bell's presentation, Trooper Maree Roger's & Joan Cruise High Tea Tablescapes.

**Action Items:** The Museum/Trooper Amos will outline a plan of action, when we can start, and presentation details (time constraints, formats ect.)

The Museum/Association/Chapters/Members-at-large will come up with topics to present and will work with the Museum to get going.

Topic: Reunion 2023 – Houston, TX

**Summary:** Captain Matthews mentioned that they are receiving a grant for the Texas parks & Wildlife, for this reunion and this will go to having a special designed project for the Jr. Buffalo Soldiers and our Youth. Maybe a campout and other activities. I mentioned we would be going to Mammoth Cave for our next Youth Summit.

Action Items: Trooper Amos will share our Mammoth Cave Youth Summit Agenda once solidified.

The Museum will work with the Buffalo Soldier Corp for Reunion 2023 and Youth Activities.

Topic: The National Association Ft. Leavenworth Museum Project

**Summary:** Our general consensus is this is a great idea for the association and it would be embarrassing to have another non-Association Buffalo Group(s) step in to build this Museum when it's all bout us and we have a GREAT opportunity to showcase us and leave a lasting legacy.
